A BRIEF INTRODUCTION ON MEOA

We are pleased to advise that our Association was established in 1931 and has as its general object the promotion, fostering and protection of the interest of the plantation industries in Malaysia. After World War II, like many other Associations, all records of the Association were lost and a public meeting was held on 26 January 1946 at which it was decided that the Association should be reactivated. Over the years, our Association has carried out its objective for which it was established.

The Management of our Association is vested in the Council which constitutes of elected representatives from the various States throughout Malaysia. These members of Council are elected during the Annual General Meeting which is normally held in March each year.

All persons, partnerships, associations and corporations (including shareholders) registered or controlled in Malaysia, who are owners or proprietors of land cultivated with economic crops in Malaysia are eligible for membership.

The annual subscription payable as fixed in our Rules of Association is as follows:

Individual member	RM300.00 per annum
Corporate member	RM2,000.00 per annum
Affiliate member	RM2,000.00 per annum
